Beverages are charged according to consumption. You nominate how much you would like to spend and what you wish to be served. Please note – that spirits, RTD's and ready mixed drinks may not be included in the dry till.

CASH BAR (BIRDIE AND EAGLE PACKAGES)

All guests pay for their own drinks.

Terms & Conditions

Confirmation of Bookings

Tentative bookings will be held for fourteen (14) days. The confirmation of bookings must be made in writing together with the signed Terms and Conditions form accompanied by the requested deposit within the fourteen days of the initial booking. Campbelltown Golf Club reserves the right to cancel any booking not confirmed within fourteen days without further correspondence.

Payment Schedule

First Deposit Upon confirmation, we require a deposit of \$1,000. This amount will be deducted from the final amount due.

Second Deposit After the initial deposit has been paid, we require a further 50% deposit based on the minimum guest numbers four (4) months prior to the event or at an agreed date as per your booking confirmation.

Final Payment The final payment is based on your final guest numbers (or minimum numbers, whichever is greater) and is required seven (7) days prior to your event.

Quoted Prices

Every effort will be made to maintain the prices originally quoted however these are subject to market conditions. All prices are confirmed 3 months prior to the event.

Cancellations

For Cancellations of confirmed bookings the following conditions apply:

- All cancellations must be made in writing.
- Provided more than one (1) month notice is given the deposit will be refunded less \$100 cancellation fee.
- If less than one months notice is given and the room is not re booked an additional \$500 cancellation fee will apply.
- If the booking is cancelled within one (1) month of the conference the deposit (less \$500 cancellation fee) will be refunded only if the room has been re-booked.
- If the conference is transferred from one date to another a second deposit is required. The original deposit will be refunded in full if the original date is re-booked.

Event Location

Campbelltown Golf Club has various available. The location of your event will be dependant on the confirmed numbers of guests attending.

Bar Service/ Drink Packages

Included in your price for both the Birdie and Eagle Packages is three (3) hours room hire with bar staff. Alcoholic beverages will not be served to persons under the age of 18 years, or to any person considered to be intoxicated. Campbelltown Golf Club and its staff reserve the right in our absolute discretion to exclude or remove any persons from the event or the Club's premises without liability.

Final Numbers

No adjustments to numbers can be made in the 7 days prior to the event.

Floor Plans

Completed floor plans for all events must be returned 48 hours prior to the event commencement.

Damages

We ask that organisers liaise with staff over display arrangements to prevent any damage to the premises. Clients will be financially liable for any damage sustained to the Club or its property. No staples, sticky or masking tape, blu tac, nails, glue or velcro may be used on any walls, door or other surface or part of the Club.

Conditions of Cart Hire

Campbelltown Golf Club have a fleet of 38 motorised carts. If you require additional carts, we may be able to assist in hiring these on your behalf. This will be charged at an additional cost. Campbelltown Golf Club will hold the organisers of the day liable for any damage that may occur to any Golf Carts during the Golf Day event. We allocate and have players cart allocation lists for, if on the unfortunate and rare occasion that damage may occur to a cart, you may then pursue the driver and passenger of that particular cart. The Group organiser(s) is responsible for all motorised carts up until all carts and keys are returned to the Pro Shop.

No Smoking

The golf course, as well as all rooms and internal areas of the Club are non smoking. Outdoor smoking areas are easily accessible from within the Club.

Food and Beverage

No food or beverage is permitted to be brought onto the Club's premises at any time. Prior arrangements for celebration cakes must be made with the Club's Functions Manager.

Any person found On Course or in the Clubhouse with alcohol not supplied by Campbelltown Golf Club will be asked to leave the premises without a refund on Golf or Catering costs.

Venue Responsibility

Campbelltown Golf Club does not take responsibility for the damage or loss of personal items before, during or after a event. No responsibility will be taken for gifts or decorations brought onto the premises.

Client Responsibility

The client is responsible for the conduct of all guests and invitees and indemnifies the Club for all costs, charges, expenses, damage and loss caused by any act or omission by the client, client's guests or invitees. It is expected that the member will conduct the event in an orderly manner and in compliance with the rules of the Club and the Law (Responsible Service of Alcohol).

Guest Sign In

Everyone entering the Club must sign in at reception. Your guests must either be a member of the Campbelltown Catholic Club, live outside the 16km radius or be signed in by a member.

Rules of the Day

All Campbelltown Golf Club Rules of Play and Dress Regulations must be adhered to during the event.

Signage and Banners

All banners must arrive 2 days prior to the event and be clearly marked with hole locations, to ensure that all banners can be set up early in the morning prior to the event commencing. Note - The Club accepts no responsibility for storage/handling of signage prior to, or after the event. All signage/banners must be taken away at the conclusion of the event.

Weather Policy

Club Management has the right to declare the course closed if it deems the course unplayable or unsafe due to extreme or inclement weather. In the event that the course is declared closed and play has not commenced, Campbelltown Golf Club will offer an alternative date at no additional fee on a space available basis. In the event that the course is declared closed and play has commenced, Campbelltown Golf Club is under no obligation to offer an alternative date for completion of the Tournament. In the event the client wishes to cancel the golf day due to actual or potential bad weather and the where the Club continues to make the course available, the client will still be required to pay the whole amount.

Event Approval

All events booked with Campbelltown Golf Club are subject to approval by the Club's Board of Directors. The Club reserves the right to vary or cancel any booking if:

- The event is deemed to oppose the objectives of the Club or may prejudice the reputation of either business
- The event is deemed to be providing goods, services or information which may be seen as inappropriate or in contradiction of the Catholic faith
- Should the Club exercise its right to cancel a booking, any deposit paid to the Club will be reimbursed in full to the client. The Club will not accept any liability for any other costs incurred by the client in relation to the booking.

All events shall be conducted in an orderly manner and comply with the rules of Campbelltown Golf Club and all applicable laws.
