

PRIVATE CART POLICY



The club will not allow members or visitors access to the golf course with a privately owned golf carts unless approval is first sought from the club's Advisory Committee (the committee), or its representative.

The committee may agree 'in principle' to a member's written request for private cart usage. Where agreed, the application will be added to the 7 day or 6 day cart waiting list, depending upon the applicant's membership status.

Applicants will be granted course access to a privately owned cart in the following circumstances:

- An applicant reaches the top of their waiting list. **An annually fee of \$240** to apply,
or
- An applicant has been on a private cart waiting list for a minimum of 3 consecutive years and has been a financial playing member of the golf club for a continuous period of at least 6 years. In this case an **annual fee of \$240 to apply**,
or
- An applicant submits a written request and is granted approval for immediate cart access. In this case an **annual fee of \$600** to apply. The approved applicant may maintain their position on the waiting list and may pay the higher amount until such time as they qualify for the lower yearly fee, as prescribed above.

In addition to the above policy the following **administrative rules** will also apply:

- Annual fees for private carts will be subject to review from time to time and will be set at the discretion of the golf club and committee.
- An applicant will have the option to take up the offer or **defer** for a period of up to 2 years. If deferred, at the completion of the second year the offer can either be taken up or the application will be rescinded.
- Approved 6 day members can only use the cart for the purpose of 'playing golf', on the days that align with their membership status. The cart can be used, at any time, when accessing clubhouse facilities.
- An applicant's position on the waiting list is subject to remaining a fully paid financial 6 or 7 day playing member of Campbelltown Golf Club. Non financial members will have their applications or approved cart access rights rescinded. Access rights are **non transferable**.
- Cart usage is limited to the applicant and **one** other nominated member, **only**. Where a second member has been nominated, they must also be a financial 6 or 7 day playing member of Campbelltown Golf Club. The approved applicant must provide the club with the details of a nominated cart user, where applicable.
- A private cart **cannot** be used on the course by other members, visitors or friends **unless** accompanied by the approved owner or the nominated member.

- The approved cart owner must provided the club with evidence of public liability insurance over the cart
- All drivers of carts must hold a current drivers license.
- Private cart usage on the golf course is subject to the same rules that may apply to road usage such as **not** driving whist intoxicated.
- The club cannot be held responsible for any damage or theft as result of private golf cart usage.
- Carts **cannot** be used outside the guidelines stated above or removal of access rights may be imposed by the committee.
- The committee reserves the right to include or remove applicants from the list as they deem appropriate. If members are removed from the list the committee will detail the reason for their removal.
- The committee reserves the right to amend this policy at any time.
